THE AMAZON DEAL DOWNLOAD

■ DEAL APPROVED

At a crowded and sometimes raucous hearing, the County Board on March 23rd approved the Arlington incentive package for Amazon to locate its HQ2 facility in newly branded National Landing, consisting of parts of Crystal City, Pentagon City and Potomac Yard in Alexandria. Amazon expects to invest around \$2.5 billion for its new headquarters project that will eventually occupy 4 million square feet of office space, potentially expanding to 6 million square feet by 2035.

■ ARLINGTON'S CONTRIBUTION

The actual Incentive Grant Agreement entered into between the County and Amazon has only two components, but the details are complicated. First, for 15 years Amazon is entitled each year to 15% of incremental hotel occupancy tax revenue expected to be generated from increased business travel to Arlington. Amazon's right to share in this tax revenue is contingent upon it meeting 90% of certain office space occupancy targets each year, starting at 64,000 square feet by July of 2020 and growing to 6,056,000 square feet by July of 2035. By then the County expects this subsidy to Amazon will reach \$23,000,000 in total. The second component is not

a direct payment to Amazon, but rather a commitment by the County to use incremental real property tax revenue generated by National Landing to fund public transportation and other infrastructure projects in and around HQ2 over 10 years beginning in 2022. The Grant



Agreement requires the County to establish a property tax baseline in 2021 and then set aside 50% of the increases in property tax revenue each year from National Landing for such projects. The County anticipates the value of this incentive to be \$28 million over the 10-year period.

■ OTHER CONTRIBUTIONS

The Commonwealth of Virginia will invest up to \$195 million in transportation projects including additional entrances to the Metro stations at Crystal City and Potomac Yard, improvements to Route 1 and a connector bridge from Crystal City to National Airport. Also, the Commonwealth offered job creation incentives that could total \$550,000,000, provided the average salary at HQ2 is at least \$150,000.

Over the next 20 years, Virginia Tech will establish a new Innovation Campus in Alexandria,

and George Mason's Arlington campus will offer new master's degree programs in computer science.

Arlington and Alexandria, as part of their already approved respective long-term Capital Improvement Plans, will invest a total of \$570 million in transportation projects and affordable and workforce housing throughout their respective jurisdictions.

■ SO WHAT DO WE GET?

What do we Old Glebe residents get out of all this, good or bad, beyond the potential use of the new transportation and other infrastructure improvements? The County projects that, taking into account the cost of the Grant Agreement, the net tax benefit to the County will be \$174,160,000 over 12 years and \$342,260,000 over 16 years. Amazon expects to create 25,000 jobs, and the current 18% office vacancy rate in Arlington should drop. On the other hand, the portion of the new Amazon employees expected to live in Arlington will add an estimated 73 to 98 students on average each year to APS' already crowded schools. It is anyone's guess as what additional pressures will be brought to bear on County roads and services, and on the price of already expensive housing. Stay tuned!

"Let it snow, let it snow, let it snow!" While our area was thankfully spared much of the snow that fell on the rest of the country, Old Glebe was prepared for it! Since the County requires that sidewalks be cleared after snowfalls, we instituted **SNOW DAYS!** a program to identify neighbors who needed help in clearing their properties, as well as a list of local service providers. Where providers weren't immediately available, generous neighbors pitched in and made sure the work was done. Starting next fall, we will update our lists and get the word out to all who might need them.

UPCOMING PRIMARY ELECTIONS

Every year has an election in Virginia, and 2019 is no exception. The general election will be held on November 5th, and we will vote as usual at the Madison Center. On the ballot will be races for State Senate (31st District), House of Delegates (48th District), Commonwealth's Attorney, Sheriff, Commissioner of Revenue, two County Board seats and the School Board.

Primaries will be held on June 11th. Only Arlington Democrats will be holding primaries or for the School Board contest, caucuses; the Arlington Republicans have not announced any primaries. In the Democratic primary State Senate race, incumbent Barbara Favola is being challenged by Nicole Merlene; and for Commonwealth's Attorney Parisa Dehghani-Tafti is seeking the Democratic nomination over incumbent Theo Stamos. Voting for these races will be at the Madison Center.



School Board candidates run in the general election without party affiliation being listed on the ballot. However, they may be endorsed by local political parties. The Arlington County Democratic Committee will hold a caucus to choose between Reid Goldstein, current Chair of the School Board, and challenger David Priddy. Three caucuses will be held: June 4 from 7 pm. to 9pm at Drew Elementary School; June 6 from 7 to 9 pm at Key Elementary School; and June 8 from 11 am to 7 pm at Washington-Liberty High School.
